Chair Greg Bowie called the meeting to order at 1:15 p.m. Bowie spoke to the chaos caused by the introduction of Bill 6 by the government. Over the next two days the delegates will be discussing Bill 6 and future funding for the organization.

Bowie spoke about the steps ABP is taking in industry funding. He addressed the dry conditions that affected most of Alberta during the spring. Bowie also spoke to the case of BSE that was discovered early in the spring. The WTO has announced the dollar value that Canada can set as tariff against the US. The Trans Pacific Partnership was signed by the Conservative government and there is hope that the new government will ratify the agreement.
