2) "Be it resolved that ABP lobby CCIA to have a \$5.00 fee charge for release of age verification of calves and that this fee be returned to cow/calf producers."

Carried – Deferred to Cow/Calf Committee and work is ongoing

3) "Be it resolved that ABP lobby the provincial government for compensation for non-margin primary producers on realized losses of devaluation of inventory regarding bred and cull cows as we have lost the ability to recover those losses due to a dysfunctional market resulting from the BSE disaster."

Carried – This is an issue that has been addressed in the past. The committee agreed to send another letter to the government regarding this issue

4) "Be it resolved that ABP lobby governments to allow beef killed and processed in our provincially inspected plants to be sold in any other province in Canada."

Carried – The issue of federal and provincial inspection is the subject of ongoing work.

5) "Be it resolved that ABP lobby the provincial government to amend section 4 of the "Cargo Securement Regulation" of the Traffic Safety Act to exempt silage from the regulation, subject to provisions similar to those given for hay and straw in section 4.1."

Carried – this issue will be addressed during the year.

6) "Be it resolved that ABP lobby the Provincial/Municipal government so that grazing lease holders be given notice of any change to the other dispositions of the lease."

7) "Be it resolved that ABP support the South West Ranchers by writing a letter to both Parks Canada and Waterton Lakes National Park,

stating that they are in opposition to releasing free roaming bison in Waterton Lakes National Park."

8) "Be it resolved that ABP oppose bill 46." Zone 2

Carried – letters were sent to Premier Stelmach and Minister Knight regarding this issue. Replies were received by February 11, 2008.

9) "Be it resolved that ABP lobby both provincial and municipal governments to support beef producers in the control of noxious weed infestations that are encouraged by energy and country residential development."

Zone 3

Carried – this will be part of the work on land use and surface rights.

10) "Be it resolved that ABP investigate the movement of wildlife throughout the province by wildlife officers and report back to the producers."

Zone 4

Motion Amended:

"Be it resolved that ABP investigate the relocation of wildlife by wildlife officers in the province and report back to producers."

Carried – investigation ongoing.

11) "Be it resolved that ABP encourages AFSC to get adjusters out to inspect wildlife damage when called on."

Zone 9

Carried – part of the work on wildlife damage and compensation.

12) "Be it resolved that ABP encourage Fish and Wildlife to deliver better fencing materials to stop wildlife from damaging hay."

Zone 9

Carried – part of the work on wildlife damage and compensation.

13) "Be it resolved that ABP lobby the provincial government to strike a working group to ensure meaningful input into the regulations arising from the Alberta Animal Health Act."

Zone 9

Carried – this lobbying is ongoing.

14) "Be it resolved that ABP lobby to increase compensation for BSE surveillance to \$500.00."

Defeated

15) "Be it resolved that ABP lobby the provincial government to reinstate lab services for Alberta producers for 3 to 5 samples per year."

"Be it resolved that ABP lobby the provincial government to reinstate vet diagnostic lab services for Alberta producers for up to 5 samples per year."

2007 Technical Committee Resolutons:

1) "Be it resolved that ABP research the potential opportunities for increased feeder and fat cattle production off grass rather than grain diets, taking into consideration the economic and environmental benefits of such a move."

2) "Be it resolved that the technical committee study the cause of and possible remedies for the high incidences of B4's in Alberta plants."

3) "Be it resolved that the ABP commission a study on weaned calf shrink from different grazing areas in Alberta."

Zone 5

Carried – ABP didn't get any data to deal with the weaned calf shrink resolution, so Reynold Bergen just reviewed the science. He has only a very crude rough draft that isn't ready to be circulated. But there's a very good internet article that appeared recently in the September 2008 Issue of Western Cowman: http://westerncowman.com/september08/dealing-with_shrink.html. When Bergen gets a chance he'll complete the report, boil it down to a one pager and run it in the Grass Routes mail out.

4) "Be it resolved that ABP lobby CFIA to provide a contingency program on a county by county basis for disease outbreak."

Carried – This will depend on CFIA and municipal jurisdiction under the FADES plan, (which the government has STILL not responded to; both Alberta Milk and Alberta Pork are after them about it as well; they want to use ours as a template), so no report is available.
